

RESOLUTION NO. 2010-07

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF FOUNTAIN HILLS, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 9, 2010.

WHEREAS, the Town of Fountain Hills (the "Town") did hold a primary election on March 9, 2010 (the "Primary Election") for the nomination/election of the Mayor and three Councilmembers; and

WHEREAS, the Primary Election returns have been presented to and have been canvassed by the Mayor and Council of the Town of Fountain Hills.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF FOUNTAIN HILLS as follows:

SECTION 1. The total number of ballots cast at the Primary Election, as shown by the poll lists was **4,540**.

SECTION 2. The number of provisional ballots was **35**, the number of conditional provisional ballots was **0**, the number of challenged ballots was **0**, the number of provisional ballots not counted was **4**; and the number of rejected early ballots was **29**.

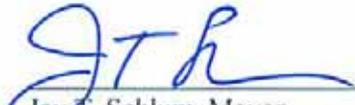
