
IT IS HEREBY ORDERED that:

7 with A.R.S. § 16-665(B)(2); (b) the Clerk of the Maricopa County Board of Supervisors
8 shall deliver to the prevailing candidate in Supervisor District 3 an official certificate of
9 election in accordance with A.R.S. § 16-665(B)(3); and (c) the Fountain Hills Town Clerk
10 shall deliver to the prevailing Council Member candidates official certificates of election
11 in accordance with A.R.S. § 16-665(B)(3).
