- ✓ *Nonpartisan Nomination Petitions signed by at least 427 and no more than 855 registered voters of Fountain Hills*
- ✓ *Financial Disclosure Statement*

## CANDIDATE CAMPAIGN FINANCE

### TO BEGIN THE PROCESS

- ★ **IF** you plan to receive or expend, *in any combination*, **more than \$500** during the election cycle, you must file a Statement of Organization. The election cycle is 01/01/2025 through 12/31/2026.
- ★ Be sure to maintain all records because **IF** you go over the **\$500** limit during the election cycle, you must file a Statement of Organization within 10 days. \*

Campaign Finance Reports will be due periodically, as indicated on the Campaign Finance Cover Sheet. While the Town Clerk's Office may send a reminder to the e-mail listed on the Statement of Organization, **it is the responsibility of the candidate to ensure reports are filed timely.**
