FILING YOUR PAPERS

- ✓ *Nonpartisan Nomination Petitions signed by at least 324 and no more than 647 registered voters of Fountain Hills*
- ✓ *Financial Disclosure Statement*

CANDIDATE CAMPAIGN FINANCE

TO BEGIN THE PROCESS

- ★ IF you plan to receive or expend, *in any combination*, more than \$500 during the election cycle, you must file a Statement of Organization. The election cycle is 01/01/2021 through 12/31/2022.
- ★ Be sure to maintain all records because IF you go over the \$500 limit during the election cycle, you must file a Statement of Organization within 10 days.

Campaign Finance Reports will be due periodically, as indicated on the Campaign Finance Cover Sheet. While the Town Clerk's Office may send a reminder to the e-mail listed on the Statement of Organization, **it is the responsibility of the candidate to ensure reports are filed timely.**
